Each phantom stock unit represents a right to be paid in cash an amount equal to the fair market value of one share of Harco Corporation Common Stock at the date of settlement. The scheduled settlement date for the phantom stock units is in annual installments over ten years to commence by January 31, 2006. Includes reinvested dividends.
- Represents restricted stock units granted under the 1995 Non-Employee Directors' Stock Plan. Each restricted stock unit has a one year vesting period and will be settled promptly following termination of the individual's service as a director of the Company.
