Item 5.02. Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

As previously disclosed in a Form 8-K filed on February 28, 2012, Harsco Corporation's (the "Company's") Board of Directors appointed Henry W. Kneueppel as Interim Chairman and Interim Chief Executive Officer ("CEO") of the Company.

In connection with this appointment, on March 7, 2012, Mr. Kneueppel received a notification letter from the Company describing his compensation arrangement for the period through which he serves as Interim Chairman and Interim CEO (the "Term"). The following describes Mr. Kneueppel's compensation arrangements with the Company:

Salary – During the Term, Mr. Kneueppel will receive a base salary of \$75,000 per month.

Incentive Compensation – In lieu of participation in the Company's short-term and long-term incentive plans, and in accordance with the terms of the Company's 1995 Incentive Plan, as amended and restated to date, Mr. Kneueppel will receive, on the first day of each of the Company's fiscal quarters that begins during the Term, an award of shares of common stock with a fair market value at the time of issuance of \$400,000. For the quarter ending March 31, 2012, Mr. Kneueppel will receive a prorated award of shares of common stock with a fair market value at the time of issuance of \$145,055. The shares granted to Mr. Kneueppel will vest immediately and will not be subject to any holding period restrictions.

Benefits and Perquisites – Mr. Kneueppel has elected not to participate in any of the Company's health and welfare, retirement or other employee benefit programs or plans. The Board has granted Mr. Kneueppel use of the Company's aircraft for his commute between the Company's headquarters in Pennsylvania and his residence in Wisconsin. The Board felt this was appropriate to lessen the disruption to Mr. Kneueppel in light of the short term nature of this assignment. The tax liability for such use will be grossed up for tax purposes. In addition, the Company will assume all housing, car rental and meal expenses associated with Mr. Kneueppel's necessary travel back and forth from his residence in Wisconsin to Camp Hill, Pennsylvania.
